Policies & Information on Health Career Programs

Effective July 1, 2024

Kankakee Community College's Health Career programs use a competitive application process. There are limits to the number of students who can enter each program annually. Therefore, admission to KCC does not mean acceptance into a Health Career Program. Steps to Apply:

- 1. Complete all KCC Admissions record and academic eligibility requirements.
- 2. Contact a health career advisor to complete program application and HESI A2 clearance.
- 3. Take the HESI A2 exam by the program deadline date.

RECORD AND RESIDENCY REQUIREMENTS

Kankakee Community College application for admission

Applicant must be accepted to the college prior to acceptance in any health career program.

Official copy of high school transcript or GED test scores:

Transcripts/Scores must be received directly from the high school or GED testing institution by KCC's Office of Admissions and Registration *if utilizing financial aid*. If you are not utilizing financial aid at KCC, you may be required to verify eligibility requirements with an unofficial transcript.

Official copies of college transcripts:

Official college transcripts must be received by KCC's Office of Admissions and registration directly from all other colleges attended if you anticipate transferring relevant coursework to complete an eligibility requirement or degree requirement. Faxes are not considered official. Transcript evaluation request forms must also be completed to have previous coursework evaluated for credit.

International Students: All foreign Transcripts must be evaluated by a member of the National Association of Credential Evaluation Services. Visit www.naces.org/members.htm for information

Residency and Cooperative Agreements

Applicants who are legal residents of the Kankakee Community College District will be given preference for admission provided all admission criteria are met. Ranking will be determined based on the residency status listed on the student record on the program deadline date. Applicants will be required to show a driver's license or State of Illinois ID as proof of residency as part of the application process, and students admitted to the program will be required to show proof of residency at the time of registration each term. The official definition of residency and description of KCC's boundaries are available in Student Services.

ACADEMIC ELIGIBLITY REQUIREMENTS

Each Health Career program at KCC has unique and individual academic eligibility requirements that prepare a student to meet prerequisites required for their core and general education curriculum. To review individual program's eligibility requirements, please visit: www.kcc.edu/healthprograms

It is the applicant's responsibility to complete their program's academic eligibility requirements and provide documentation prior to the testing deadline.

- A grade of C or better is required for all coursework.
- Unless noted, all placement/assessment tests must have been completed with the last 2 years.

In-progress coursework

An applicant must be able to verify that they are in-progress with science requirement(s) and the Certified Nursing Assistant course (if applicable) by providing a current transcript (either official or unofficial) with the course listed as registered or in-progress during the semester in which the program deadline falls. The course(s) must be completed with a final grade posted and verified, prior to the specified program's start date.

Applicants enrolled at KCC must be registered for the course(s) and verified through Colleague that the course is inprogress and will be completed prior to the program start date.

If a student receives a grade of "D", "F", withdraws, or has an incomplete as the final outcome of the course that was allowed to be in-progress, eligibility for/acceptance to the that program will be automatically nullified.

GPA

Students with college credit at KCC, you must have a minimum cumulative grade point average (GPA) of 2.5 on a 4.0 scale. Students without a KCC GPA can also be accepted. Any student who has completed <u>all</u> general education requirements (with a C or better) for a program can apply for a program with the exception noted on the application. At the program director's discretion, a student may be accepted conditionally with a student learning contract.

Applicants who reside outside of KCC's district who receive the same program entry considerations as in-district students must have the required GPA at the cooperative agreement granting institution. GPAs from four-year institutions are not considered in the application process.

A student who has previously completed any competitive entry program classes can exclude grades from those courses when applying for re-entry to that program or a new program (with approved appeal). This student should complete the KCC Grade Forgiveness Appeal once accepted into the new program.

Student GPA will be verified on the application deadline date. The minimum GPA of 2.5 must be maintained until that year's program begins or eligibility for/acceptance to that program is automatically nullified unless an exception has been approved through the Health Careers Appeal process.

HESI A2 entrance exam

Applicants are allowed two HESI A2 testing attempts per application cycle (Summer/Fall or Spring) for which they complete an application.

Students may use Hesi scores from a previous application cycle if the test was taken 12 months or less from the application date. Applicants must decide at the time of application to use previous scores and indicate that intent on the application. If the applicant does not use previous scores, they will have 2 Hesi attempts during the application cycle. An applicant cannot revert to previous scores once a new Hesi attempt is taken.

The HESI A2 test is administered by computer, which is the same as how health career exams are administered. The results are calculated by HESI. KCC faculty/staff will not recalculate your score. HESI A2 must be completed at KCC and scores are valid for one year.

Program Selection

Applicants will be ranked for program acceptance based on HESI A2 test scores. The higher of the two attempts will be used for ranking. Eligible applicants who are not offered a seat will be alternates. Students will be notified of their status in writing.

If a choice must be made among several applicants with the same test score, selection for admission will be made on the basis of:

- 1. Completion of the greatest number of non-MEDT, -PMED, -PHTA, -PNUR, -RESP, -RNUR or -XRAY courses in the curriculum. If a tie still occurs, then
- 2. The highest comprehensive score(s) in the area of science on the HESI A2 Exam. If a tie still occurs, then
- 3. The highest comprehensive score(s) in the area of reading on the HESI A2 Exam.

ADDITONAL PROGRAM INFORMATION

Before applying, students should review the list of essential physical capabilities and essential functions should possess in order to successfully complete each health career program available online at kcc.edu.

The curriculum of record for those applying to, but not yet accepted into, competitive entry health careers programs is the Associate in General Studies.

Any student who accepted a seat and started a KCC Health Careers program and did not complete the program will be required to submit a Health Careers Eligibility Appeal or Application for Re-Entry to be considered for any future application cycles in other programs. Students can only enter KCC Health Career Programs twice without successful completion, whether that be the same program or different programs.

A student may only apply to up to 3 health career programs per application cycle (Summer/Fall or Spring). Students applying to multiple programs in a semester must indicate both programs on their program application. Applicants will have the opportunity to choose which program they accept a set. For nursing, applicants will first be considered for RN and if not accepted, will be ranked for PN.

Clinical learning experiences are part of all Health Careers programs. Students must follow their clinical site's policies, which may include vaccination requirements.
